MINUTES OF THE MIDWEST TENNESSE AREA SERVICE COMMITTEE (ASC) OF NARCOTICS ANONYMOUS – JANUARY 27, 2013

Area Chair, Angie E., opened the meeting with the reading of The Twelve Traditions, The Twelve Concepts of Service, and The definition and purpose of an Area Service Committee.

Area Chair Report: Angie E. reported that she visited the Gift of Desperation Group on January 16th and it was a wonderful meeting. Jason R. has reserved our meeting room here for the next year and is passing the contact information on to the next Chairperson so we can continue to meet here.

Secretary's Report: Report was accepted and the minutes for January 6, 2013 were approved.

<u>Treasurer's Report</u>: Presented by Clinton S. The Treasurer's report was accepted. The balance at the end of the meeting was \$121.53

<u>Hospitals and Institutions (H&I) Sub-Committee Report</u>: Presented by Scott B. for the H&I Chair. Tim B. and Charles M. spoke at Aspell Recovery earlier this month. He stated that H&I needed more literature.

Convention Subcommittee Report: Presented by Sarah H. There was discussion on the budget concerns for the convention and the lack of participation at fund raisers. The Convention was discussed regarding not having the money to pull off a convention. Concerns regarding how NA would be affected, as a whole, and especially this area due to a poorly planned convention and how there is no possible way to raise the amount of money which was over \$3000. The deposit of \$900 was discussed to see if it can be put toward a 2014 Convention or if the Hotel would recoop some of the deposit. After much discussion concerning lack of communication with the Convention committee, Christine M. and Dustin H. were elected, as an Ad Hoc Subcommittee, to go to the Convention meeting at 7 PM on January 27th. Their objective is to assist the Convention Subcommittee with getting the convention delayed, rescheduled, or canceled. Update: On January 28th, Jeremey P, Convention Chair, contacted the hotel and they are not willing to work with us in any way in changing the date of the convention. The Convention Committee is going to meet on February 10th to discuss it further and consider the options. If it is decided to cancel the convention, then the Convention Committee and Convention Adhoc Committee will work together to discuss and decide what to do with the money that has been raised. Further information will be provided when it becomes available.

Discussion regarding possibly having a Valentines Dance in February and having Area Picnic in May and will be at the next Area meeting.

She will take the suggestions from Area back to her home group and set up a meeting with the landlord and take another trusted servant to the meeting with her.
- Meeting schedules totaling 100 were printed last month and not all groups received enough schedules. It was voted to print an additional 50 schedules. Scot B. was given a check for \$23.00 for 150 schedules to print out.
- There are 13 books that we are trying to locate that were passed down to James, the H&I Chair. There is very little literature for Aspell Recovery and JACOA. There was a vote

to order the H&I DVD & Guidebook for \$8.75 and to order more literature to take to H&I locations.

POLICY AND PROCEDURE:
